Business arising from the minutes none.

Guest Speaker: Christopher Justice - Councillor

**Presented:** The municipality is aware of the **condition of Adelaide St.** (bumpy, uneven), it is on the priority list, but the funds in the capital program are limited and they are hoping for an increase in the capital asset account are proceeding with caution with their spending.

Concerns about the aggressive **motorcyclists** on our streets and in the forest reserve: There is not much the Muni can do, they are aware and ask that we call the RCMP and Bylaws.

**Remediation of the Slag** at Crofton waterfront is beyond the Muni's ability. If pushed, the Muni will pressure the Provincial and Federal governments. A

petition or focus group would be helpful bringing it to the Muni's attention. Chris proposed a Notice of Motion regarding the slag at the municipal council meeting last night. He asked for history and a report on the slag itself and what is the benefit of removal and asked for recommendations of first steps. This motion will be made in 2 weeks. If passed it will start the process. He asked for letters and attendance at the meeting.

**Charlotte Fisher** – Asked if bylaws could post **signs** at the 2 entrances to the trails on to Robert St. Can we put signage there? In the last 6 weeks she noted the yellow gate on Osborne Bay Rd. Opposite Maple Mountain Park access was left open. She closed it after a couple of days. She phoned it in, it took days to be locked. She also would like 'no firearms' signs at the gates like at the top of Robert St. lake trail entrance and at the other entrances as there is evidence of off season shooting.

**Dan Robin**— Talked to some kids riding **motorcycles**, told them they were being watched and should be not riding on the roads. Has noticed that they swap out drivers on the motorcycles. Dan also believes that in 1902 \$1200.00 was paid to the federal government by the smelter owner to use for slag cleanup.

**Charlie** – How long until **Herd Rd.** is ready near new hospital. **Chris**: Muni will do bridgework at the same time as the roundabout so as not to close the road twice.

## Osborne Bay Terrace: Rick reported for Linda Lockhart

- Osborne Bay Terrace participated in the annual member teams meeting of all
  housing providers that use the BC Housing registry database, which is what we
  access when we have a vacancy, (which we don't currently have), there we will
  find a BC Housing pre-approved listing of possible tenants to choose from.
- We also use this site to submit subsidy information for tenants. Currently,
   Osborne Bay Terrace applies for tenant subsidy and collects the same, the
   tenant pays the difference. This will change in 2028, after BC Housing, tenants
   will move to a different subsidy system, probably SAFER, where tenants apply
   for and receive their subsidy direct; Osborne Bay Terrace will collect the
   approved rent only.
- We are in the process of setting up dates for routine annual maintenance as contractors have long wait lists.

• We are moving the downstairs rentals to the upstairs for the summer to accommodate Youth Group.
